SERVICES ARE OFFERED ON A SLIDING FEE SCALE, REGARDLESS OF THE INDIVIDUAL'S ABILITY TO PAY. IN FY17, SAFE ALLIANCE COUNSELORS OFFERED 1,929 COUNSELING HOURS TO 535 SEXUAL ASSAULT SURVIVORS AND THEIR LOVED ONES.
