CLINICAL SERVICES: SAFE ALLIANCE (SA), FORMERLY UNITED FAMILY SERVICES (UFS), IS AN OUTPATIENT MENTAL HEALTH PROVIDER WHICH PROVIDES TRAUMA INFORMED, EVIDENCE BASED COUNSELING TO CHILDREN AND ADULTS EXPERIENCING EMOTIONAL TRAUMA USING LICENSED CLINICIANS. LAST YEAR, SA SERVED 2,380 INDIVIDUALS AND FAMILIES WITH 8,469 HOURS OF COUNSELING ACROSS FOUR COUNTIES. NINETY-SIX PERCENT OF OUR CLIENTS SERVED SAID THEIR COUNSELING EXPERIENCE WAS HELPFUL IN ADDRESSING THEIR PROBLEMS, DECREASING THEIR SYMPTOMS AND IMPROVING DAILY FUNCTIONING. IN FY15, SAFE ALLIANCE MADE THE STRATEGIC DECISION TO FOCUS ON THE AGENCY'S CORE SERVICES IN MECKLENBURG COUNTY. IN FY16, WE DISCONTINUED OUR GENERAL MENTAL HEALTH COUNSELING, AND WILL PROVIDE COUNSELING SERVICES ONLY TO VICTIMS OF DOMESTIC AND SEXUAL VIOLENCE AND CHILD ABUSE.
