CLINICAL SERVICES: SAFE ALLIANCE(SA) PROVIDES TRAUMA INFORMED MENTAL HEALTH COUNSELING SERVICES TO CHILD AND ADULT SURVIVORS OF SEXUAL ASSAULT LIVING OR WORKING IN MECKLENBURG COUNTY. SERVICES ARE OFFERED ON A SLIDING FEE SCALE, REGARDLESS OF THE INDIVIDUAL'S ABILITY TO PAY. IN FY16, SAFE ALLIANCE COUNSELORS OFFERED 1,699 COUNSELING HOURS TO 698 SEXUAL ASSAULT SURVIVORS AND THEIR LOVED ONES. 90% OF THOSE WHO COMPLETED COUNSELING SESSIONS DEMONSTRATED SYMPTOM REDUCTION AND AN IMPROVED ABILITY TO FUNCTION IN DAILY LIFE. IN THE FIRST TWO MONTHS OF FY16, SAFE ALLIANCE OFFERED GENERAL MENTAL HEALTH COUNSELING SERVICES IN CABARRUS AND UNION COUNTIES, SERVING 174 INDIVIDUALS.
